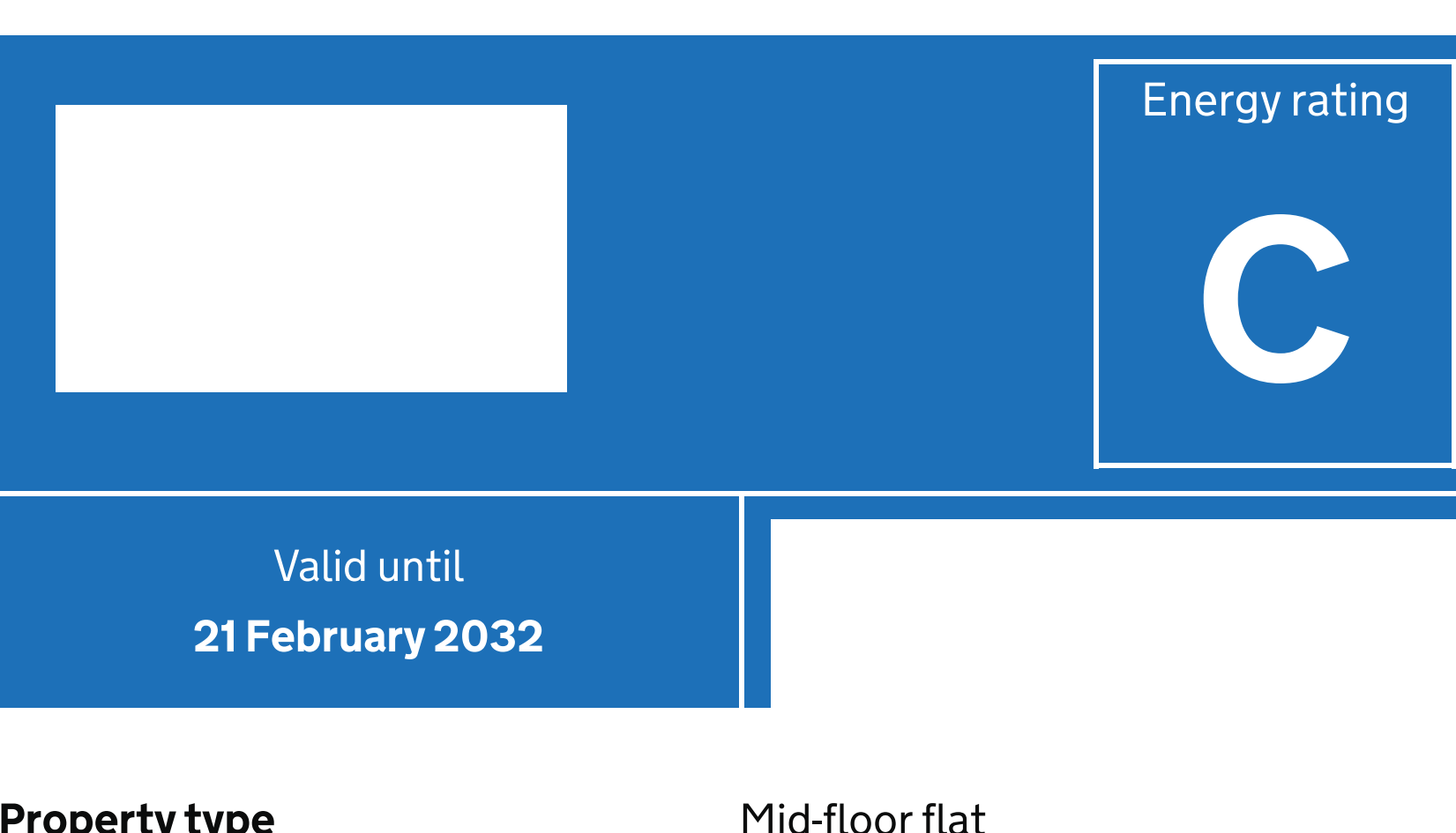

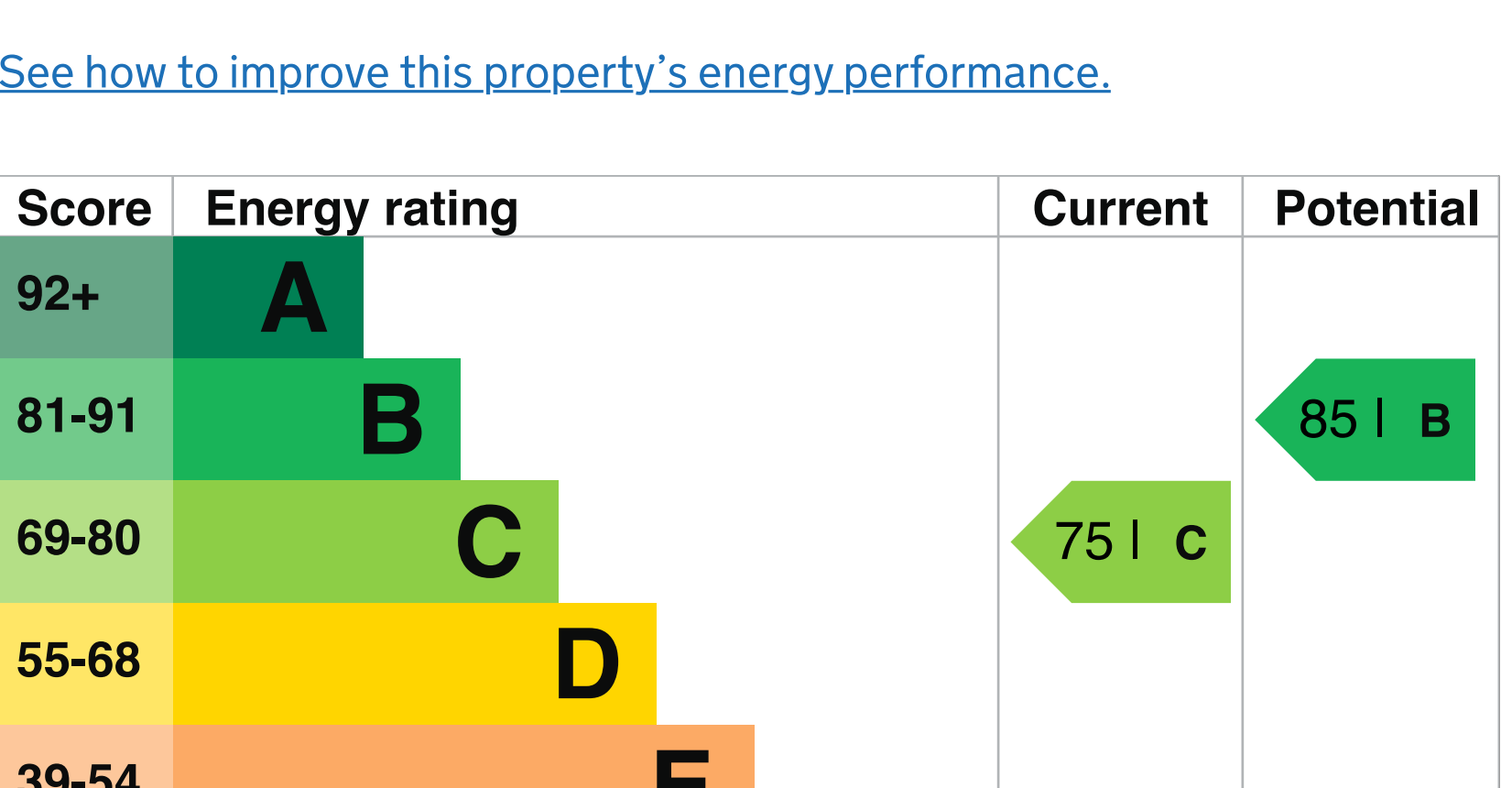
Properties can be rented if they have an energy rating from A to E.

## Environmental impact of this property

This property's current environmental impact rating is C. It has the potential to be B.
