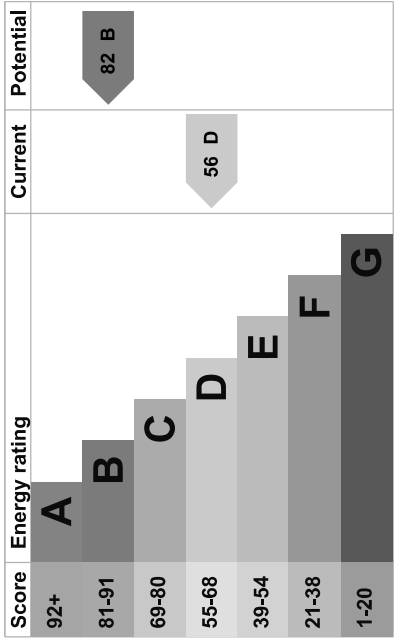

## Primary energy use

## How this affects your energy bills
