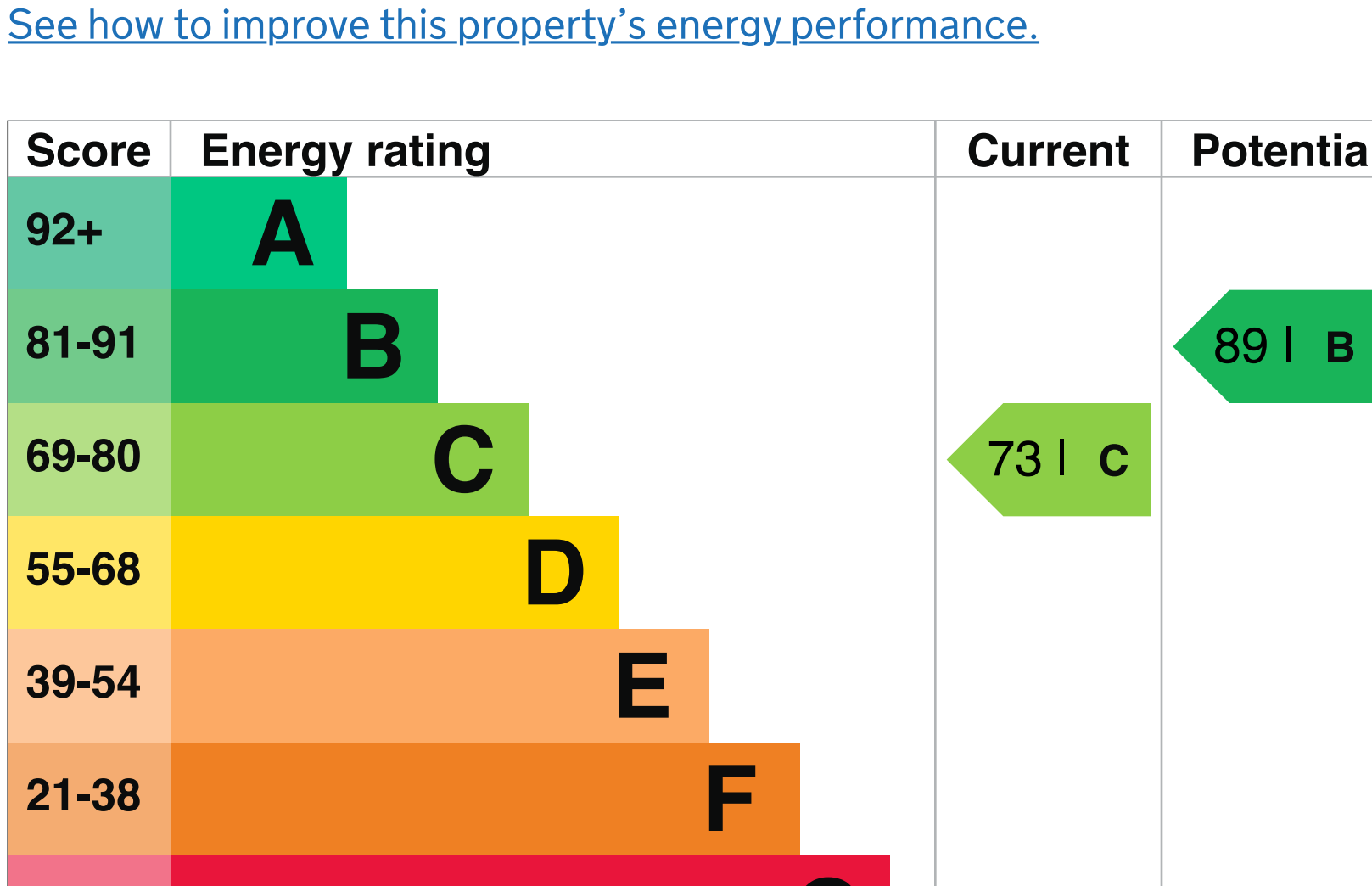

## Environmental impact of this property

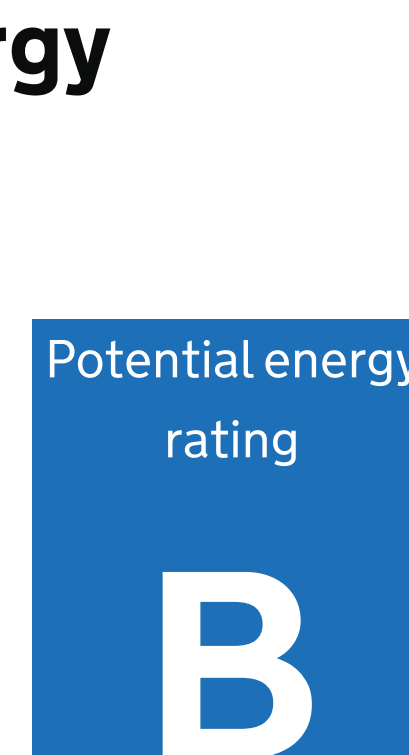

### Step 1: Floor insulation (solid floor)

### Step 2: Low energy lighting
